### COVID-19 Case Update in Warren County May 9 – May 15, 2021

The Warren County Health Department is announcing 6 additional confirmed case of coronavirus disease (COVID-19), bringing the total cases to 1772. 1711 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 49 confirmed COVID-19 related deaths.
