### COVID-19 Case Update in Warren County May 30 – June 5, 2021

The Warren County Health Department is announcing 3 additional confirmed case of coronavirus disease (COVID-19), bringing the total cases to 1804. 1747 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 51 confirmed COVID-19 related deaths.
