COVID-19 Case Update in Warren County July 18–July 24, 2021

The Warren County Health Department is announcing 8 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 1835. 1777 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 53 confirmed COVID-19 related deaths.
