## COVID-19 Case Update in Warren County July 25–July 31, 2021

The Warren County Health Department is announcing 8 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 1843. 1783 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 53 confirmed COVID-19 related deaths.
