### COVID-19 Case Update in Warren County August 1–August 7, 2021

The Warren County Health Department is announcing 25 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 1868. 1804 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 53 confirmed COVID-19 related deaths.
