COVID-19 Case Update in Warren County August 8–August 14, 2021

The Warren County Health Department is announcing 29 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 1897. 1821 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 53 confirmed COVID-19 related deaths.
