## COVID-19 Case Update in Warren County August 29 – September 4, 2021

The Warren County Health Department is announcing 61 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 2037. 1905 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 54 confirmed COVID-19 related deaths.
