COVID-19 Case Update in Warren County October 10 – October 16, 2021

The Warren County Health Department is announcing 33 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 2403. 2308 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 65 confirmed COVID-19 related deaths.
