COVID-19 Case Update in Warren County November 7 – November 13, 2021

The Warren County Health Department is announcing 37 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 2521. 2420 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 67 confirmed COVID-19 related deaths.
