### COVID-19 Case Update in Warren County November 28 – December 4, 2021

The Warren County Health Department is announcing 58 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 2629. 2497 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 68 confirmed COVID-19 related deaths.

County level COVID-19 metrics for **Week 47** from **November 21-November 27, 2021** for Warren County indicate we still have **high community transmission**.
