### COVID-19 Case Update in Warren County December 5 – December 11, 2021

The Warren County Health Department is announcing 70 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 2699. 2545 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 68 confirmed COVID-19 related deaths.

County level COVID-19 metrics for **Week 48** from **November 28-December 4, 2021** for Warren County indicate we still have **high community transmission**.
