### COVID-19 Case Update in Warren County December 26, 2021 – January 1, 2022

The Warren County Health Department is confirming 1 additional COVID-19 related death. The individual was a female between the ages of 40-60. Our deepest sympathy goes out to family and friends. We continue to urge our community to do what you can to slow the spread of the virus and to get vaccinated

The Warren County Health Department is announcing 151 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 3003. 2798 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 71 confirmed COVID-19 related deaths.
