COVID-19 Case Update in Warren County February 20 – February 26, 2022

The Warren County Health Department is announcing 16 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 3893. 3801 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 81 confirmed COVID-19 related deaths.

County level COVID-19 metrics for **Week 7** from **February 13 – February 19, 2022** for Warren County indicate we are now **STABLE for community transmission**.
