COVID-19 Case Update in Warren County March 6 – March 12, 2022

The Warren County Health Department is confirming 1 additional COVID-19 related death. The individual was a female between the ages of 60-80. Our deepest sympathy goes out to family and friends. We continue to urge our community to do what you can to slow the spread of the virus and to get vaccinated.

The Warren County Health Department is announcing 2 additional confirmed cases of coronavirus disease (COVID-19), bringing the total cases to 3909. 3817 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 82 confirmed COVID-19 related deaths.
