COVID-19 Case Update in Warren County March 13 – March 19, 2022

The Warren County Health Department is announcing 1 additional confirmed case of coronavirus disease (COVID-19), bringing the total cases to 3910. 3827 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 82 confirmed COVID-19 related deaths.
