COVID-19 Case Update in Warren County March 27 – April 2, 2022

This will be our last weekly update for COVID-19 cases. With the availability of home tests which are not reported to IDPH and that facilities will no longer be reporting negative tests, percent positivity is not an accurate way to monitor for community transmission. Metrics will be focusing on community transmission based on new cases, hospitalizations and ICU availability. Illinois Department of Public Health and CDC have made valuable updates to their websites with the latest guidance and COVID-19 statistics. The health department will continue to monitor for new cases and potential outbreaks, conduct testing, and offer COVID-19 vaccinations.

The Warren County Health Department is announcing 4 additional confirmed case of coronavirus disease (COVID-19), bringing the total cases to 3917. 3834 cases have had their symptoms resolve. Due to federal privacy restrictions, release of any additional information is prohibited. To date there have been 83 confirmed COVID-19 related deaths.
